Schools of Choice in Lapeer County

Each of the constituent districts of the Lapeer County Intermediate School District (ISD) – Almont Community Schools, Dryden Community Schools, Imlay City Community Schools, Lapeer Community Schools, and North Branch Area Schools – has Section 105 and 105c Schools of Choice Programs. These programs operate in accordance with Sections 105 and 105c of the State School Aid Act. Section 105 allows local school districts to enroll non-resident students who reside in other local school districts within the same ISD. Section 105c allows local school districts to enroll non-resident students who reside within the boundaries of an ISD that is contiguous to Lapeer County.
