

Extended COVID-19 Learning Plan Reconfirmation Required 30 Days after Initial Plan Approval and Every Month Thereafter

Requirements:

- Reconfirm how instruction is going to be delivered during the 20/21 school year
- Public comments from parents and/or guardians on the Extended Learning Plan
- Review weekly 2-way interaction rates

Reconfirmation Items for November

Reconfirm instructional delivery method:

The Lapeer ISD's plan is to utilize in-person instruction in its programs involving K-12 students. This instructional delivery method is altered only in the event of a mandated shutdown of school, the result of a recommendation from the Lapeer Health Department for closure or quarantine, or should one of its early college partners choose to provide instruction virtually. Should any of these situations occur, the ISD implements its plan for virtual instruction, outlined in its 2020-21 Preparedness and Response Plan.

Note: The Michigan Department of Health and Human Services (MDHHS) issued an Emergency Order effective December 7, 2020 which provided for in-person instructional delivery for Career and Technical Education under certain conditions. We are developing a plan in accordance with guidance from the Michigan Department of Education's Office of Career and Technical Education to provide in-person instruction, in collaboration with the ISD's local constituent districts. However, the Lapeer Health Department has recommended the Education & Technology Center not open for in-person instruction at this time, citing:

- A higher than state average test positivity rate;
- A higher than state average daily new case per 100K rate;
- A higher than state average infection rate; and
- A higher than state average ICU room usage rate.; and
- The fact that returning to in-person would bring a large number of students and staff to one location.

Should the recommendation of the Lapeer Health Department change, we plan to return to in-person instruction for Career and Technical Education students on January 4th. Center Program students continue to receive in-person instruction, as class size is very small.

Reconfirm how instruction will be delivered for each grade level:

The delivery method of instruction for each grade level in the Center Program is in-person. As outlined above, instruction for high schools students in the Career and Technical Program as well as those students in the STEMM Academy early college program will be conducted remotely until January 4th, 2021.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

The Lapeer ISD has established structures for general and special education teachers and/or providers to collaborate and communicate regarding student performance and student needs on IEP goals and objectives with special consideration regarding assistive technology and accessibility.

The ISD ensures a continuation of services for students receiving speech and language, occupational therapy, physical therapy, or social work services within their IFSP or IEP. The district also ensures a method for the continuation of evaluation for students suspected of having a disability as well as those requiring re-evaluation.
