Supplemental Security Income (SSI) is a federal income supplement program funded by general tax revenues (*not* Social Security taxes):

- It is designed to help aged, blind, and disabled people who have little or no income; and
- It provides cash to meet basic needs for food, clothing, and shelter

If you are under age 18 we may consider you "disabled" if you have a medically determinable physical or mental impairment, (including an emotional or learning problem) that:

- results marked and severe functional limitations; and
- can be expected to result in death; or
- has lasted or can be expected to last for a continuous period of not less than 12 months.

SSI for Adults

If you are age 18 or older we may consider you "disabled" if you have a medically determinable physical or mental impairment (including an emotional or learning problem) which:

- results in the inability to do any <u>substantial gainful activity</u> (earnings averaging less than \$1,180 a month for the year 2018); and
- can be expected to result in death; or
- has lasted or can be expected to last for a continuous period of not less than 12 months

Ticket to Work

The Ticket to Work (Ticket) program is a free and voluntary program that can help Social Security beneficiaries go to work, get a good job that may lead to a career, and become financially independent, all while they keep their Medicare or Medicaid. Individuals who receive Social Security benefits because of a disability and are age 18 through 64 probably already qualify for the program.

MiABLE (Achieving a Better Life Experience) account www.miable.org

A tax-free Achieving a Better Life Experience (ABLE) account lets people with disabilities save for their future without affecting their SSI, Medicaid, SNAP and other benefits. It also lets family and friends give them money. The first \$100,000 in an ABLE account will not impact SSI eligibility, allowing persons with SSI benefits to work.

Guardianship Age 18

A guardian is someone appointed to make legal decisions for another person (called the ward) that has a developmental disability. Guardianship is the legal proceeding in court. When a court gives powers to a guardian, they take those same rights away from the ward. Students are automatically their own guardian when they turn 18 years of age unless a guardian is appointed by probate court.

Most people with a disability are able to take care of their own lives without a guardian. There are alternatives to guardianship that can meet the needs of an individual without going to court. Everyone is different, and what works for one situation may not work for another. Some examples of alternatives to guardianship may include a limited bank account, trust fund, power of attorney, etc.

In order to complete the guardianship process, forms can be obtained from Lapeer County Probate Court, beginning with the "Petition For Appointment of Guardian, Individual with Alleged Developmental Disability." A current psychological report is required along with the petition.
