

An App Worth Checking Out

“SnapType”



SnapType helps students keep up with their peers in class even when their penmanship holds them back. Students can easily complete school worksheets with the help of an iPad or iPhone.

Snap Type is described as an Occupational Therapy app that helps students who have difficulty writing. Students can take pictures of their worksheets in class and use the iPad keyboard to type in answers.



New Reform Regarding Medicaid Autism Applied Behavior Analysis Services

Michigan Department of Health and Human Services Behavioral Health
and Developmental Disabilities Administration



Medicaid Autism ABA

- April 1, 2013 – December 31, 2015 Michigan Medicaid covered Applied Behavior Analysis services for children with ASD from age 18 months through 5 years of age under a 1915(i) state plan authority

NEW PART

- Effective January 1, 2016 Michigan Medicaid provides coverage of Applied Behavior Analysis (ABA), for children under 21 years of age with ASD

Medicaid Autism ABA

All children, including children with Autism Spectrum Disorders (ASD), must receive EPSDT services that are designed to assure that children receive early detection and preventive care, in addition to medically necessary treatment services to correct or ameliorate any physical or behavioral conditions, so that health problems are averted or diagnosed and treated as early as possible.

Special Education: An Advocate's Manual



Glossary of Abbreviations



This is a summarized list taken from the Michigan Protection & Advocacy Service Glossary of Abbreviations & Terms:

- ASD Autism Impairment or Autism Spectrum Disorder
- ALJ Administrative Law Judge
- AT Assistive Technology, devices or supports to help a student with a disability learn more effectively
- BIP Behavior Intervention Plan, plan to address inappropriate behavior
- BSP Behavior Support Plan, plan to prevent inappropriate behavior by addressing its underlying causes and replacing them with appropriate behaviors
- CI Cognitive Impairment
- DB Deaf-Blind, a disability which may qualify a student for special education services
- DOE U.S. Department of Education, state agency responsible for implementing Federal and state special education laws
- ECDD Early Childhood Developmental Delay, a disability which may qualify a young child for special education
- EI Emotional Impairment
- ESEA Elementary and Secondary Education Act, formerly know as "No Child Left Behind"
- ESY Extended School Year, educational program that extends beyond the regular school year
- FAPE Free Appropriate Public Education, the standard special education services set by Federal law which all schools must meet
- FBA Functional Behavior Assessment
- HH Homebound and Hospitalized, educational services to students who cannot attend school because of health limitations
- HI Hearing Impairment, disability which may affect educational performance, may qualify a student for special education services
- IDEA Individuals with Disabilities Education Act, Federal law which requires states to provide special education and related services to students with specified disabilities
- IEE Independent Educational Evaluation, evaluation by an expert chosen by a student or parent, sometimes paid for by a school district
- IEP Individualized Education Program, written plan which sets forth a student's present level of performance, goals and objectives, and services and timelines to meet the goals and objectives
- IEPT Individualized Education Program Team, a team including parents, teachers, administrators and service providers which writes and implements the Individualized Education Program
- IFSP Individualized Family Service Plan, written plan which sets forth a young child's present level of performance, goals and objectives, and services (including family support services) and timelines to meet the goals and objectives
- LD Learning Disability
- LEA Local Education Agency
- LRE Least Restrictive Environment, concept requiring schools to educate students with disabilities in the same setting with other student when possible

SLI	Speech and Language Impairment
SCI	Severe Cognitive Impairment
SXI	Severe Multiple Impairments, combinations of disabilities which may affect educational performance
TBI	Traumatic Brain Injury
